- "Whereas RSA 655:14 states, "The name of any person shall not be printed upon the ballot of any party for a primary unless he or she is a registered member of that party"; AND
- Whereas members of the Libertarian Party sign a pledge certifying they "do not believe in or advocate the initiation of force as a means of achieving political or social goals;" AND
- Whereas Tom Alciere has a history of advocating killing police officers and other violent acts: AND
- Whereas Tom Alciere has refused to take a pledge against violence as a means of obtaining political objectives; AND
- Whereas the Libertarian Party of New Hampshire revoked and refunded the membership of Tom Alciere in 1993 because of his anti-social views and refusal to sign the Libertarian Pledge; AND
- Whereas former LPNH Chair Danielle Donovan said, "[The situation] could have been disastrous had we not had such a strong response. Every opportunity to denounce Alciere was considered successful."; AND
- Whereas Tom Alciere has filed to appear on the Libertarian Party primary ballot for US House in District 2:
- BE IT THEREFORE RESOLVED, The Libertarian Party of New Hampshire Executive Committee to the extent possible under the laws, statutes and regulations of NH disavows, impugns, forswears and repudiates Tom Alciere as a Libertarian candidate."
